E invoicing limit of Aggregate turnover reduced from 10 crores to 5 crores with effect from 1st August 2023.

Impact: With effect from 1st August, 2023, every registered taxable person whose aggregate annual turnover exceeds INR 5 Crore in any of the FY starting from 2017-18 shall liable to issue E-Invoice. Currently this limit is 10 Crores.
